Read: Proposals received from Principals of Govt. Colleges

In the Annual Plan of 2018-19 an amount of Rs.400 Lakhs (Rupees Four Hundred Lakhs Only) is provided under the Head of Account "2202-03-103-74 - Accreditation of Colleges with National Assessment and Accreditation Council (N.A.A.C)". The Provision under this scheme is intended to equip colleges to obtain accreditation/re-accreditation with NAAC.

The Principals of Government Colleges have submitted proposals for the financial assistance in this scheme. After examining the proposals, sanction is here by accorded for the allotment of funds to those colleges whose NAAC accreditation is already due and who have to obtain accreditation/reaccreditation as the case may be with in 2020, subject to certain general conditions.

- 2. ADHOC/Advance release of funds before expenditure becoming due will not be allowed
- 3. The total expenditure will be limited to the Current Year's Budget Provision.

4. Stores Purchase Rules should be strictly followed.

5. For the construction work, time of completion should be specified.

- 6. If accredited agency is executing the works, time of completion along with "Penalty Clause" should be included in MOU/Agreement.
- 7. For PWD works, PRICE software should be adopted.

The Principal should observe all the procedural formalities and relevant rules while utilizing the fund. Principal must do a regular monitoring of the work progress and has to report to this office periodically

The expenditure on this account will be met from the Head of Account 2202-03-103-74 - Accreditation of Colleges with National Assessment and Accreditation Council (N.A.A.C) scheme in the current year's budget.
