- M.Ed. Degree from a recognized University or equivalent (ii)
- Candidates should have cleared the National Eligibility Test (NET) for Assistant . (iii) Professors conducted by the University Grants Commission/ Council for Scientific and Industrial Research or similar Test accredited by the University Grants Commission ("Good Academic Record" means at least second class with fifty percent marks in Graduation Degree.)

candidates, who are or have been awarded Ph.D. Degree in compliance of the University Grant Commission (minimum standards and procedure for award of Ph.D. Degree), Regulation, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET for recruitment and appointment of Assistant Professor or equivalent positions in university/ colleges/ institutions.

Note 2: Relaxation of 5% may be provided from 55% to 50% of the marks at the Master's level for the SC/ST category.

Note 3: Relaxation of 5% may be provided form 55% to 50% of the marks at the Master's level and 5% relaxation at graduate level at par with SC/ST candidates to the physically and visually handicapped.

Note 4: Relaxation of 5% may be provided from 55% to 50% of the marks to the Ph.D. Degree holder who have passed Master's Degree prior to 19th September 1991.

Note 5: B in the 7 point scale with letter grades O, A, B, C, D, E and F shall be regarded as equivalent of 55% wherever the grading system is followed.

Note 6: Relaxation of minimum marks at the PG level from 55% to 50% may be provided to candidates who have cleared the Junior Research Fellowship Examination conducted by University Grant Commission/ Council of Scientific and Industrial Research only prior to 1989 when the minimum marks required to appear for J.R.F. examination was 50%.

Note 7: The exact requirement of the subject/ discipline will be indicated at the time of each recruitment.

Note8:Qualifications are relaxable at the discretion of the Union Public Service Commission in case of candidates otherwise well qualified.

The applications in the prescribed form (Annexure-A) of suitable officers who satisfy the educational qualifications and experience who can be spared may be sent to this Department. The final selection of the candidate will be made in consultation with the Union Public Service Commission.
