ORDER

In the current year's budget there is a provision of Rs 40lakhs under the Head of Account "2204-00-104-29(02)-Assistance to DCE for the conduct of Sports".The amount is provided for the promotion of Sports & Physical Education in Govt. Colleges under the Directorate of Collegiate Education.

Out of this Rs 40 Lakhs ,an amount of Rs 33,15,000/-(Rupees Thirty Three Lakhs Fifteen Thousand only) had already been allotted to 45 Govt.Colleges as per the reference read as 1st above.Principals of Govt.Colleges have requested financial assistance under this scheme

After examining the proposals submitted by the principals ,sanction is hereby accorded for the allotment of **Rs 5,20,000/- (Rupees Five Lakhs Twenty Thousand only)** to the following Govt.Colleges as shown below.
