## **ORDER**

In the current year's budget(2017-18) there is a provision of Rs 800 lakhs under the head of account 2202-03-103-75-01-College infrastructure upgradation programme(plan) .The purposes of the scheme are 1) Construction of building for colleges and hostels 2) Minor construction works for general improvement in facilities 3)Maintenance of playgrounds and improvement of sports facilities 4)Conservation of heritage value of colleges and hostels 5) Purchase of sports goods and 6)Students amenities.

Out of Rs 800 lakh ,an amount of Rs 7,21,65,000 /-(Seven Crore Twenty One Lakhs Sixty Five Thousand only) had already been alloted to the Government Colleges and Hostels under this department as per the proceedings read as 1 st above .Principals and Wardens of the Govt. Colleges and Hostels have submitted proposals for financial assistance under this scheme.
