ORDER

As per the Government orders read as 2nd & 3rd paper above, the remuneration of the Guest Lecturers was enhanced at Rs. 500/-per teaching hour subject to the ceiling of Rs. 25,000/- for those having UGC prescribed qualification and Rs. 300/- per teaching hour subject to the ceiling of Rs. 20,740/- for those without UGC prescribed qualification, working in Government and Aided Arts & Science Colleges, Music Colleges, Training Colleges and Physical Education Colleges under Collegiate Education Department. The Director of Collegiate Education as per letter read as 9th paper above and various service organizations also have requested to enhance the remuneration of Guest Lecturers working in Government and Aided Arts & Science Colleges, Music Colleges, Training Colleges, Sanskrit Colleges and Physical Education Colleges.

Government have examined the proposal in detail and are pleased to revise the remuneration of the daily waged/contract teachers coming under the Collegiate Education Department/ Technical Education on daily wage basis as specified below:

- a) UGC qualified hands - Rs.1750/- per day subject to a maximum of Rs.43,750/- in a month on daily wage basis.
- b) Non UGC hands - Rs.1600/- per day subject to a maximum of Rs.40,000/- in a month on daily wage basis.
- c) The work load, teaching hours etc shall be in accordance with the existing norms applicable to regular teachers.

The date of effect of the enhanced daily wage will be with effect from 01.04.2017.
