### <u>ORDER</u>

In the current year's Budget 2018-19 there is a provision of Rs.100 Lakhs under the Head of Account "2202-03-103-61- New Government Autonomous colleges and New Government Deemed Universities of Kerala(Plan)". The Principal of Maharaja's College, Ernakulam as per letter 1st cited has requested to give sanction and allotment of an amount of Rs.5.61 Crore towards recurring and non- recurring expenses related to Autonomy. But in the current years outlay for this scheme Government have provided only an amount of Rs 100 lakhs. In order to clear the four pending bills related to 2017-18 posted in the treasury queue an amount of Rs.16,13,826/-(Rupees Sixteen Lakh Thirteen Thousand Eight Hundred and Twenty Six Only) had to be allotted from the current years(2018-19) budget

amount. Therefore the balance amount available under this scheme is only Rs.83,86,174/-. Since the recurring expenses related to Autonomy has to be sanctioned immediately for smooth conduct of examination and other related work, the Principal, Maharaja's College, Ernakulum has requested vide letter 2<sup>nd</sup> cited to sanction the balance available amount of Rs.83,86,174/- (Rupees Eighty Three Lakhs Eighty Six Thousand One Hundred and Seventy Four Only). In the above circumstances, administrative sanction and allotment of fund for Rs.83,86,174/- (Rupees Eighty Three Lakhs Eighty Six Thousand One Hundred and Seventy Four Only) is hereby accorded as detailed below as per the proposal of the Principal.
