In the current year's Budget 2018-19 there is a provision of Rs.200Lakhs under the Head of Account "2202-03-105-99-Faculty Development 34- Other Charges (Plan)". After examining the proposals an amount of Rs.1,95,25,000/-(Rupees One Crore Ninety Five Lakhs Twenty Five Thousand Only) is sanctioned for 60 Government Colleges as shown against the name of the college. The expenditure under this scheme should be limited to the allotted amount.
