ORDER

Consequent to the implementation of the Government Orders cited in reference above, it has been pointed out that Guest Lecturers engaged have been drawing remuneration more than the regular Assistant Professors in a few cases. The Director of Collegiate Education has pointed out this discrepancy and sought certain clarification on the Government Orders read above. Government have examined the request and are pleased to issue the following further clarifications to the Government Orders read above :

1. 'Per lecture' means a period of one hour.
2. A Guest teacher who possess the prescribed qualification for the post of Assistant Professor and who has performed duties for atleast 50 teaching hours per month shall be eligible for a Honorarium of maximum of Rs.25,000/- per month reckoned at the rate of Rs.500 per teaching hour. A Guest Teacher who is engaged for less than 50 teaching hours per month shall be eligible only for the pay proportionately. However, no additional Guest Teacher shall be appointed for hours exceeding 50 teaching hours and having workload less than 5 hours.

To ensure the smooth conduct of academic work in colleges, Guest Teachers may be appointed against all vacancies on the basis of the work load assessed for teaching the course, regardless of whether the post itself is a sanctioned one. However, it will be the responsibility of the Principal / Deputy Director of Collegiate Education to ensure that based on the assessment of work load as is applicable for the course structure of a given subject, the appointment of Guest lecturer(s) is necessary and justified.

The Government Orders read above stand modified prospectively from the date of this order to the above extent only.
