## ORDER

In the current year's budget 2017-18 there is a provision of Rs. 1000 lakhs under the head of account "2202-03-103-58-Innovative courses including Honours Programmes and Community courses in Government Colleges and Universities (Plan)". As per the Government Order read I<sup>st</sup> Government have accorded Administrative sanction for the construction of Buildings B.Com. (Honours) for Government Victoria College, Palakkad for an amount of Rs. 2 crores only (Rupees Two crores only).

In the circumstances Administrative Sanction is hereby accorded to the Principal for executing the above work for an amount of Rs. 2 crores only (Rupees Two crores only). The utilization of the amount shall be made only after observing all procedural formalities as stipulated in the relevant rules and Government Orders in force and also subject to the observance of Store Purchase Rules wherever applicable and subject to certain general conditions mentioned below and also the following particular condition.

- 1. The release of funds will be need based when actual expenditure falls due.
- 2. Adhoc/Advance release of funds before expenditure becoming due will not be allowed.
- 3. The total expenditure will be limited to the Current Year's Budget provision.
- 4. If Computer Purchase is involved concurrence of Stores Purchase Department should be obtained. Circular No. 25/16/Fin. dated 01/06/2016 should be strictly followed.
- 5. E-Tender system should be followed.
- 6. Stores Purchase Rules should be strictly followed.
- 7. For construction work, time of completion should be specified.
- 8. If accredited agency is executing the works time of completion along with Penalty Clause should be included in MOU/Agreement.
- 9. For Government works, PRICE software should be adopted.

## Particular condition

The proposal for Rs. 200 lakh is approved as per estimate of PWD to be built in accordance with master plan with no cost escalation. The above work should be completed by May 2019.

The expenditure on this account will be met from the head of account "2202-03-103-58-Innovative Courses including Honours Programmes and Community Courses in Government Colleges and Universities (Plan)" in the current year's budget.
