ORDER

In the current year's budget (2018-19)there is a provision of Rs 900 lakh under the head of account 2202-03-103-75-01-College Infrastructure Upgradation Programme(Plan) .The purposes of the scheme are 1) Construction of building for colleges and hostels 2) Minor construction works for general improvement in facilities 3)Maintenance of playgrounds and improvement of sports facilities 4)Conservation of heritage value of colleges and hostels 5) Purchase of sports goods and 6)Students amenities.

As per the decision of the departmental working group for the Higher Education Department which met on 26.03.2018, Government vide G.O 3st cited accorded administrative sanction for the following proposals in financial year 2017-18 and directed to furnish necessary reappropriation proposals along with proposals for transfering funds to Electronic Ledger Account (E-LAMS) before 31.3.2018.

In the above circumstances ,Administrative Sanction is hereby accorded and a total amount of Rs 646 Lakh (Six Hundred and Forty Six Lakh Only) is allotted under the head of account 2202-03-103-75-01-CIUP to the 4 Govt.College Principals as shown below.
