In the Annual Plan of 2018-19 an amount of Rs.400 Lakhs (Rupees Four Hundred Lakhs Only) is provided under the Head of Account “2202-03-103-74 - Accreditation of Colleges with National Assessment and Accreditation Council (N.A.A.C)”. The Provision under this scheme is intended to equip colleges to obtain accreditation/re-accreditation with NAAC.

As per the reference cited, the Principal of T M Jacob Memorial Govt. College Manimalakunnu has requested for sanctioning a total amount of Rs. 14,20,000/- (Fourteen Lakh, Twenty Thousand Only) for the below mentioned purposes for the preparatory works regarding the NAAC team visit to the college during May 2018

**General Conditions**

1. The release of the funds will be need based when actual expenditure falls due.
2. ADHOC/Advance release of funds before expenditure becoming due will not be allowed
3. The total expenditure will be limited to the Current Year's Budget Provision 2018-19.
4. Stores Purchase Rules should be strictly followed.
5. For the construction work, time of completion should be specified if accredited agency is executing the works, time of completion along with "Penalty Clause" should be included in MOU/Agreement.

The Principal should observe all the procedural formalities and relevant rules while utilizing the fund. Principal must do a regular monitoring of the work progress and has to report to this office periodically

The expenditure on this account will be met from the Head of Account "2202-03-103-74 - Accreditation of Colleges with National Assessment and Accreditation Council (N.A.A.C)" scheme in the current year's budget.
