Vide circular No.17/2019/Fin dated.26/02/2019, the government have instructed to submit the data of all employees of the departments/Universities/LSGDs before 8 th March 2019 for implementing the new medical Insurance Scheme for State Employees and Pensioners (MEDISEP) .
