ORDER

In the current year's Budget 2017-18, an amount of Rs.400 lakhs has been allotted under the head of account "2202-03-103-74-Accreditation of colleges with NAAC 34 Other charges (Plan)". The provision under this scheme is intended to equip colleges to obtain accreditation/re-accreditation with NAAC. The Principals of Government Colleges have submitted proposals for financial assistance under this scheme. After examining the proposals funds are sanctioned to 31 Govt.Colleges amounting to Rs.196.3 lakhs(one crore nintysix lakh nd thirty thousand rupees only) as shown against the name of each college. The Principals concerned will initiate necessary urgent action to complete the formalities for inviting Quotations/Tenders etc. In order to get accreditation/ reaccreditation, necessary guidance will be provided by the State Co-Ordinator of Quality Assurance Cell, NAAC, and whose TA/DA for the purpose may be given from this amount as per rules.
