Ref:- Letter No.6275/1T-CeIl/2016/NCC dated 20.12.2016 from the Additional Director General, NCC, Thiruvananthapuram.

I am to inform you that as a part of implementation of E-Governance, NCC Department has introduced an Office Automation Software which include 12 Modules viz. Cadet, Training, Finance ,Audit, Establishment,Inventory, Assets, Publicity, Reports, Admin, Messaging, and Reference, designed by MIs Kéltron, Thiruvananthapuram. Cadet module is one of the most important module, the details of which are highly required for organizing many of the routine activities of the NCC. In the cadet module of this software, the details of NCC Cadets of all educational institutions are to be uploaded by Associate NCC Officers of respective institutions wherever NCC troops/companies are allotted. Since the Internet facility is not extended to ANOs by their Head of Institutions , they are experiencing difficulties in uploading the cadet data and posting requisite fields of BIMS/BAMS (e-Portal for claim settlement), for claiming cadet's Refreshment allowance, Washing allowance, Honorarium, etc.

In view of the above, I am to request you to issue formal permission letters to the institutions under your control for providing internet access in a separate Computer system to Associate N.C.C. Officers, without invoking additional financial commitment (average use reported is one hour per week) for facilitating the uploading of cadet data/Claim entry.
