Subject: Extension of last date for the Institute Registration on National Scholarship Portal(NSP) under Scholarship Schemes for FY 2019-20.

## Sir/Madam,

Please refer to my letter of even number dated 29.07.2019 addressed to the Chief Secretaries of all States/UTs regarding the implementation of the 3 Scholarship Schemes for students of minority communities viz. Pre-Matric, Post-Matric and Merit-cum-Means by this Ministry through the National scholarship Portal (NSP) during 2019-20

2. It was intimated that the process of registration of Institutes/Schools has been very slow and all State/District Nodal Officers need to be advised to be proactive in verification of all Institutes/Schools that are applying for re-registration/fresh registration. During the National Workshop on the implementation of the Scholarship Schemes held at New Delhi on 19<sup>th</sup> August 2019 it was agreed that registration of Institutes/Schools would be completed on the NSP by 31<sup>st</sup> August 2019.

3 However, as per the State-wise 'Institution Registration Report' available on NSP as on 05<sup>th</sup> September 2019 (copy enclosed), there is still a huge difference in total number of Institutes to be registered and the number of re-registered Institutes for 2019-20 under all three Scholarship Schemes. A total of 13,15,793 institutes, against 14,72,229 Institutes registered during the last year, are yet to apply for registration on the NSP. Out of the 1,56,436 Institutes that have applied so far for registration 40,358 Institutes are pending for verification by the States/UTs/Districts.

4. The slow progress in registration of Institutes/Schools will adversely affect the verification of applications by these Institutes/Schools and delay the entire process. It is pertinent to mention here that Cabinet Secretariat (DBT Mission) has made it clear that there would no extensions in the time lines decided for the various activities on the NSP this year and the last date for first level verification (i.e. Institute/School level verification) for Pre-Matric Scholarship Scheme shall be 31.10.2019 and that for Post-Matric & Merit cum Means based Scholarship Schemes the last date shall be 15.11.2019.

5. In view of the foregoing, it is requested to direct the Nodal Officer of each Scheme to complete the registration/verification process of all Institutes/Schools in your State/UT by 15.09.2019 so as to enable us to follow the prescribed timelines of NSP.
