ORDER

Government had introduced Centralized Numbering System for TR-5 Receipts as per G.O. read above with a view to prevent the chance of malpractices while receiving public money. However, it was permitted to use the old manually numbered TR-5 receipts till its stock was fully exhausted.

- 2. Now it has come to the notice of Government that a large number of offices are still using the old type of receipts on the strength of the provision in the G.O cited which allows the use of old receipts till its exhaustion. Keeping of bulk stock of old receipts has also been noticed in certain offices.
- 3. Government having reviewed the position, are pleased to order that the use of TR-5 receipts bearing Centralized Number System will be mandatory with effect from 1.7.2013. The unused stock of old TR-5 receipts remaining as on this date will be destroyed and appropriate entries made in the stock register.
 - 4. Necessary amendments to KTC Vol. I & II will be issued separately.
