The funds were not made available in that financial year and the amount was not posted in E-LAMS. The Departmental working group meeting of Higher Education Department held on 15.05.2018 considered the proposal to accord revised administrative sanction to the tune of Rs.38,44,900/- (Rupees Thirty Eight Lakh Forty Four Thousand Nine Hundred only) and Government vide reference 4th cited revised Administrative Sanction for an amount of Rs.38,44,900/- (Rupees Thirty Eight Lakh Forty Four Thousand Nine Hundred only).
