As per the reference 2nd cited the Principal of Maharajas College Ernakulum has requested for purchasing UV Visible Spectrometer instead of Surface Enhanced Raman Spectrometer in the proposal because of the present cost of the equipment exceeds the amount earmarked for the equipment.
