In the Annual Plan of 2018-19 an amount of Rs.200 Lakh (Rupees Two Hundred Lakh Only) is provided under the Head of account-2202-03-001-96-Modernization of Directorate and Zonal Offices under Directorate of Collegiate Education. As per the Reference 1 st cited Departmental Working Group for Higher Education Department held on 12.10. 2018 has considered the proposal forwarded by the Director of Collegiate Education for constructing Deputy Directorate Office Kottayam and Administrative Sanction has been accorded as per the G.O 2 nd cited limited to an amount of Rs 150Lakhs as mentioned below .

As per reference cited 3rd Government has accorded administrative sanction for an amount of 75 lakhs(Rupees Seventy Five lakhs only) to in the current financial year for the first phase construction of Deputy Directorate Office Kottayam . The remaining amount will be allotted to this project as expenditure fell on due, subject to certain general conditions.

General Conditions

1. The release of the funds will be need based when actual expenditure falls due.
2. ADHOC/Advance release of funds before expenditure becoming due will not be allowed.
3. E-Tender system should be followed.
4. Stores Purchase Rules should be strictly followed.
5. For the construction work, time of completion should be specified.
6. If accredited agency is executing the works, time of completion along with "Penalty Clause" should be included in MOU/Agreement.

The Deputy Director must do a regular monitoring of the work progress and has to report to this office periodically. The utilization certificate should also be furnished in due course. The expenditure on this account will be met from the Head of Account 2202-03-001-96-Modernization of Directorate and Zonal Offices under Directorate of Collegiate Education in the current year's budget (2018-19) provision.
