In the Annual Plan of 2018-19 an amount of Rs.100 Lakhs (Rupees Hundred Lakhs Only) is provided under the Head of Account “2205-00-101-99 Music Colleges-34- Other Charges -3 Other Items (Plan)”. Government have posted an amount of Rs 16,00,000/- (Rupees Sixteen lakhs only) of SRV College of Music and Performing Arts Thrissur, and an amount of Rs 6,51,365/- ((Rupees Six Lakhs Fifty One Thousand Three Hundred and Sixty Five only) of Sree Swathy Thirunal Government College of Music Thiruvananthapuram in e-LAMS under the Head of Account “Music colleges and Academies 2205-00-101-99- for the financial year 2017-18 as per the e-LAMS register No 125/2018 and 25/2018 respectively.

As per the GO cited 1st Government have accorded sanction to release an amount of **Rs 16,00,000/- (Rupees Sixteen lakhs Only)** which was posted in e-LAMS under the e-LAMS Register No.125/18, to SRV College of Music and Performing Arts Thrissur.

As per the GO cited 2nd, Government have accorded sanction to release an amount of **Rs 6, 51,000/- (Rupees Six Lakhs Fifty One Thousand only)** which was posted in e-LAMS, under the e-LAMS Register No.25/18, to Sree Swathy Thirunal Government College of Music Thiruvananthapuram.

Therefore sanction is here by accorded for the allotment of funds as mentioned below.
