## <u>ORDER</u>

In the Annual Plan of 2020-21 an amount of Rs.200 Lakh (Rupees Two Hundred Lakh Only) is provided under the Head of Account "2202-03-103-61-Autonomous colleges and establishing Lead Colleges as Integrated Education Hubs"

As per the reference cited, the Principal of Maharajas College Ernakulam has requested a total amount of Rs. 1,43,00,000/- (Rupees One Crore Forty Three Lakh Ony) for the Establishing and Functioning of Autonomous College.

After examining the proposal, administrative sanction is hereby accorded for the allotment of fund for a total amount of **Rs. 57,40,000/- (Rupees Fifty Seven Lakh and Forty Thousand Only)** to below mentioned purposes, subject to certain general conditions.

## **General Conditions**

- 1. The release of the funds will be need based when actual expenditure falls due.
- 2. ADHOC/Advance release of funds before expenditure becoming due will not be allowed.
- 3. The total expenditure will be limited to the Current Year's Budget Provision.

4. Stores Purchase Rules should be strictly followed while utilizing the amount. The Principal should also ensure that the allotted amount is released only for the specific purposes mentioned above. The Principal should observe all the procedural formalities and relevant rules while utilizing the fund. Principal must do a regular monitoring of the work progress and has to report to this office periodically. The utilization certificate should also be furnished in due course.

The expenditure on this account will be met from the Head of Account "Autonomous colleges and establishing Lead Colleges as Integrated Education Hubs-2202-03-103-61" scheme in the current year's (2020-21) budget.
