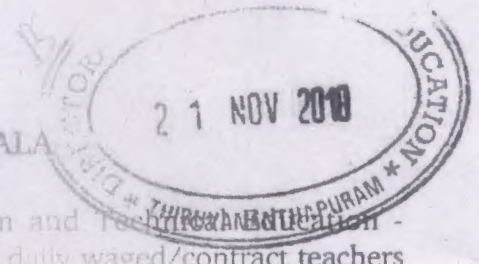

ORDER

As per the Government orders read as 2<sup>nd</sup> & 3<sup>rd</sup> paper above, the remuneration of the Guest Lecturers was enhanced at Rs. 500/- per teaching hour subject to the ceiling of Rs. 25,000/- for those having UGC prescribed qualification and Rs. 300/- per teaching hour subject to the ceiling of Rs. 20,740/- for those without UGC prescribed qualification, working in Government and Aided Arts & Science Colleges, Music Colleges, Training Colleges and Physical Education Colleges under Collegiate Education Department. The Director of Collegiate Education as per letter read as 9<sup>th</sup> paper and Director of Technical Education as per letter read as 11<sup>th</sup> paper above and various service organizations also have requested to enhance the remuneration of Guest Lecturers working in Government and Aided Arts & Science Colleges, Music Colleges, Training Colleges, Sanskrit Colleges, Physical Education Colleges, Engineering Colleges and Polytechnic Colleges.

Government have examined the proposal in detail and are pleased to revise the remuneration of the daily waged/contract teachers coming under the Collegiate Education Department/ Technical Education as follows:

- a) UGC /AICTE qualified hands - Rs.1750/- per day subject to a maximum of Rs.43,750/- in a month.
- b) Non UGC/non-AICTE hands - Rs.1600/- per day subject to a maximum of Rs.40,000/- in a month.



c) The work load, teaching hours etc shall be in accordance with the existing norms applicable to regular teachers.

The date of effect of enhanced wages will be from 01.04.2017. The Government Order issued vide letter read as 10<sup>th</sup> paper above stands modified to the above extent.


