Ref:- Letter no. 23/2012-ERS(Vol-III) dated 27.08.2012 from the Election Commission of India, New Delhi.

The Election Commission of India vide their letter cited has ordered Special Summary Revision of Electoral Rolls with 01.01.2013 as qualifying date. With a view to enhance the participation of youth in the electoral process of the country, the Election Commission of India has carried out various measures to improve the percentage of enrollment of youth in the Electoral Roll. The Commission is very keen to enrol all the eligible citizens, especially the youth who are the newly qualified electors. The campaign for enrollment of 18-19 age group

in the electoral roll, conducted during January this year, as part of Special Summary Revision of electoral rolls, 2012 was a big success.

A similar campaign is being organized this time also, during the month of October 2012, as part of Special Summary Revision of Electoral Roll, 2013. But this time, the campaign will cover those in the age group of 19-20 also, along with 18-19 age group, for enrollment in the electoral roll.

In order to facilitate the students for hassle-free enrollment, we have decided to send a team of election officials to the colleges on pre-advertised dates, during the period of this campaign. The team will register the names of fresh electors born before 2.1.1995 who have not registered their names elsewhere. The students can enrol their names in that Part (Polling Station) of the Legislative Assembly Constituency where their parents are enrolled as voters.

I request you to give necessary instructions to the head of institutions under your jurisdiction to co-operate with the Election Officials and to provide them with necessary facilities for the smooth conduct of the special campaign. If possible, a computer system with Internet connection may also be made available for this purpose. Adequate publicity in this regard will be given by this department, in respective areas.
