## **ORDER**

As per the Government Orders read first and third above, sanction have been accorded to M/s Kerala Small Industries Development Corporation Limited (SIDCO) for supplying Wooden Furniture directly to all Government Departments/Public Sector Undertakings/Local Self Government Institutions/ Autonomous Bodies etc., without following tender formalities, in relaxation of para 57(a)(ii) of Stores Purchase Manual (para 9.23 of the revised Stores Purchase Manual, 2013). Initially this relaxation had been granted for a period of one year and subsequently it has been extended from time to time.

The period of validity of relaxation extended, vide the Government Order read 4th above expired on 19-11-2013. The Managing Director, SIDCO in his letter read 5th above has requested Government to extend the period of validity of the relaxation for a further period of two more years from 20-11-2013, so as to enable them to supply Wooden Furniture directly to all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc., without observing tender formalities.

Government have examined the matter in detail and are pleased to issue orders extending the period of validity, in relaxation of para 9.23 of Stores Purchase Manual for a further period of one more year with effect from 20-11-2013, so as to enable SIDCO to supply Wooden Furniture directly to all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies etc., without observing tender formalities. The price of the Wooden Furniture should be in accordance with the price fixed as per the G.O. (Rt.) 11/2009/SPD dated 11-2-2009 and which is appended as Annexures I, II and III to this order.

All Government Departments, Public Sector Undertakings, Local Bodies, Autonomous Institutions etc., can purchase their requirement of Wooden Furniture directly from SIDCO without observing tender formalities and as per the rates in the Annexures I, II and III appended to this order for a further period of one year from 20-11-2013.
