- 3. Circular No.03/2012/Fin dated 06/01/2012

As per the Circulars read above, Government have issued instructions to Government Departments, State Public Sector Undertakings/Autonomous Institutions etc restricting parking of funds provided by Government in Banks and Financial Institutions. As per these instructions the Government funds shall be parked in treasuries only and the funds unutilized shall be resumed to State Government at the end of every financial year.

In spite of these instructions, it has come to the notice of Government that, funds provided by Government to Government Departments/ PSUs/Autonomous bodies etc for various purposes are kept in Banks, Financial Institutions etc under SB, FD etc without having utilized for the purpose for which the same has been sanctioned.

All HODs/CEOs of State PSUs/Autonomous Institutions are hereby instructed to provide the details of Government funds parked in Treasuries/Banks in the proforma appended to Finance(SL) Department with a copy to Director of Treasuries within two days positively. Director of Treasuries shall furnish consolidated and updated details of the above information to Government on or before 5th of December 2013.
