ORDER

In the Annual Plan of 2020-21, an amount of Rs.70 lakhs (Rupees Seventy lakhs only) is provided under the Head of Account "2202-03-103-81 - Training Colleges".The scheme aims to make the four Govt Teacher's Training Institutions under the Department of Collegiate Education capable of providing good training for the teacher trainees with a view to impart better education to the students.

As per Order cited 1st, amount was allotted to GCTE Kozhikkode & GBCTE Thalassery for the purchase of goods. Principals of above said colleges have informed that the Bills regarding the purchase of goods could not be generated in BIMS and hence the amount could not be spent during the financial year 2019-20. Therefore the Principals of these Colleges have requested a re-allotment with regard to the same as per reference 2nd & 3rd cited.

After examining the proposals, sanction is hereby accorded to re-allotment funds for the above said purpose as mentioned below.
