ORDER

Government, as per the first paper read above, have issued orders implementing Sixth UGC Pay Revision Scheme for teachers in Universities and Colleges. Subsequently Government as per the order read as second paper above decided to disburse the arrears of Sixth UGC Pay Revision in four installments and accorded sanction for the release of first installment of arrears for the period from 01.01.2006 to 30.06.2007. As per the Government order read as third and fourth paper above sanction were accorded for the release of second and third installment of UGC pay revision arrears for the period from 01.07.2007 to 30.06.2008 and 01.07.2008 to 30.06.2009.

2) As per the fifth paper read above, the Director of Collegiate

Education have furnished the details of the amount required by the six Universities in the State for the disbursement of salary arrears. Government have examined the matter in detail and are pleased to accord sanction for the release of the fourth installment of arrears of the sixth UGC Pay revision for the period from 01.07.2009 to 31.03.2010 as given below, subject to the terms and conditions in the Government order read as second paper above.
